**IF ON SKIN OR CLOTHING:** TAKE OFF CONTAMINATED CLOTHING. RINSE SKIN IMMEDIATELY WITH PLENTY OF WATER FOR 15-20 MINUTES.

**IF INHALED:** MOVE PERSON TO FRESH AIR. IF PERSON IS NOT BREATHING, CALL 911 OR AN AMBULANCE, THEN GIVE ARTIFICIAL RESPIRATION, PREFERABLY MOUTH TO MOUTH IF POSSIBLE.

**IF IN EYES:** HOLD EYE OPEN AND RINSE SLOWLY AND GENTLY WITH WATER FOR 15-20 MINUTES. REMOVE CONTACT LENSES IF PRESENT, AFTER THE FIRST 5 MINUTES, THEN CONTINUE RINSING EYE.

## DIRECTIONS FOR USE

**PLEASE NOTE – THERE IS NOT ENOUGH SRS Pond Dye Black, Got Muck?, or SeaThru INCLUDED IN THIS MAINTENANCE KIT FOR INITIAL APPLICATIONS.**

THIS KIT IS ONLY INTENDED TO BE APPLIED EVERY 2-4 WEEKS FOR THE UPKEEP OF WATER FEATURES AFTER A SUCCESSFUL INITIAL TREATMENT WITH THESE PRODUCTS.

INCREASE OR DECREASE THE SUGGESTED APPLICATION RATES OR FREQUENCY OF APPLICATIONS FOR DESIRED RESULTS.

**SRS Pond Dye Black:** TOSS 1 WATER SOLUBLE BAG INTO THE WATER FEATURE FOR EACH SURFACE FOOT OF WATER.

**Got Muck?:** ADD AN ENTIRE PACKET (70 TABS) INTO THE WATER FEATURE FOR EACH SURFACE ACRE OF WATER.

**SeaThru:** INITIALLY ADD 4 - 8 POUNDS OF SEATHRU FOR EACH SURFACE ACRE OF WATER. EVERY 4 WEEKS, ADD 4 POUNDS OF SEATHRU TO MAINTAIN CLARITY.

## STORAGE AND DISPOSAL

### DO NOT FREEZE

**STORAGE:** STORE IN A COOL, DRY PLACE OUT OF SUNLIGHT. PRODUCT MUST BE STORED BETWEEN 68 AND 100 F. MICROBES WILL REMAIN VIABLE FOR TWO YEARS WHEN STORED AS DIRECTED.

**DISPOSAL:** DISPOSE OF BAGS AND CARDBOARD BOX IN A MANNER ALLOWED BY LOCAL, STATE AND FEDERAL LAWS AND REGULATIONS.
